- **Secure and Robust Data Import:** Zoom Audit's import engine allows you to import financial records and eliminate data entry time.

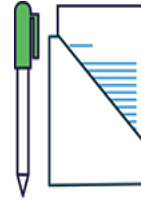

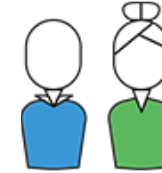
## About your Premium Audit Process
